Textual Information()

The Ministry of Corporate Affairs (MCA) vide Notification dated June 14, 2018 notified the Companies (Significant Beneficial Owners) Rules, 2018 (amended by Companies (Significant Beneficial Owners) Amendment Rules, 2019) (hereinafter referred as SBO Rules) under which various requirements pertaining to disclosures regarding Significant Beneficial Owners have been specified. The details in Shareholding Pattern pertaining to the Significant Beneficial Interest to be filed with BSE Limited under Regulation 31 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 can be filled only if BEN-1 is received directly by the Company. Please also note that it is pertinent to note that Gokak Textiles Limited, being a listed Company is not a wholly owned subsidiary of the Holding Reporting Company and neither the SBO Rules nor SEBI Regulations provides for disclosing proportional holding on the basis of BEN-1 received by the Reporting Holding Company. As Gokak Textiles Limited is required to file BEN-2 with the CIN of Reporting Holding Company and in the absence of receipt of BEN-1 directly, in our bonafide interpretation, the requirement of reporting of Significant Beneficial Interest is not applicable to Gokak Textiles Limited under Regulation 31 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.
